## **COPYRIGHT COMPLIANCE**

### **FAIR USE**

1. The purpose and character of the use, including whether such use is of a commercial nature or is for non-profit, educational purposes
2. The amount and substantiality of the portion used in relation to the copyrighted work as a whole
3. The nature of the copyrighted work
4. The effect of the use upon the potential market for or value of the copyrighted work.

LaGuardia’s Library Media Resources Center maintains both its print and electronic reserve collection following the guidelines of 17 U.S.C. Section 107. Placing materials on reserve is at the initiative of the faculty member solely for the non-commercial, educational usage of the students. If a user makes a request for or later uses a photocopy or reproduction for purposes in excess of “fair use,” that user may be held liable for copyright infringement. This institution reserves the right to refuse to accept a reserve request, if in its judgment, fulfillment of the order would involve violation of copyright law.
